

TOWN OF WEST SWEDEN-Monthly meeting September 20, 2022

Chairman Meier called the meeting to order at 6:30 pm. Present were Terry Taylor, supervisor, Jerry Tischer supervisor, Phyllis Wilder, clerk, Lori Lundquist, and Chris Tewalt, patrolman. John Schommer, Sue & Mike Jahnke, residents.

The clerk presented August meeting minutes, approved as presented. Correction of Blom Lake Dr not Bloom Lake Rd as written in the minutes.

The treasurer presented the August financial report, thanked the treasurer for her report.

Public input- Mike Jahnke questioning why/when will Blom Lake Drive be returned to blacktop, feels that this road is a major through fare. Expressed that the board should notify residents when they are planning to do road work prior to work being done.

Unfinished Business

Summer road work: Hopkins planning are getting gravel on Blom Lake Dr next week. Have patched the 310th Ave and Clam Falls Drive culvert areas that were replaced in May.

Building updates: Tyler worked on the roof, has found larger holes than screws will cover. There are three patches of metal on the roof currently.

Update of fire & street signs: Will be getting class B signs soon from Rent a Flash and stops signs will be going up at 160th and 300th Ave on Wednesday, September 21.

Utility ordinance 2022-01: Recommend sending a copy of ordinance to the local utilities registered return receipt. Adoption of ordinance, Supervisor Tischer motion to adopt, Supervisor Taylor seconded, voice vote Ayes: 3, Nays: 0 motion carried.

Bridge on 350th update on repairs: Polk County Hwy Department has ordered the materials for the repairs caused by the accident. Person that hit bridge does not have insurance, possible small claims or retaining an attorney to recoup costs. Estimate of materials is \$2433 plus labor.

Sub-division-Wikstrom property: Motion by Supervisor Taylor, seconded by Supervisor Tischer to approve the subdivision, carried.

Salt sand shed report: Inspection was completed March 8, 2022.

Adopt resolution 2022R-01 to amend budget: Table until after budget meeting Thursday, October 6 at 8:30 am.

Dog complaints: Have received two complaints about dogs, one dog biting walkers and one a dog attacking neighboring dogs.

Employee/Highway Report: Need use agreement for blacktop patching equipment completed and signed by chairman and village president.
